ore than 17,600 grants and program distributions totaling \$51.3 million were awarded from Dayton Foundation funds this past fiscal year (July 1, 2018, to June 30, 2019). In the last decade, the Foundation has distributed more than 152,000 grants totaling \$439.7 million – an impressive sum that shows the impact The Dayton Foundation and its donors have made in the region and beyond.

Students Have a Bright Future, Thanks to Scholarships

More than 1,400 students are making their educational dreams a reality, thanks to \$2.1 million in scholarships awarded by 197 Dayton Foundation funds. This amount includes more than \$856,000 awarded by the Dayton-Montgomery County Scholarship Program and Montgomery County Ohio College Promise, both funds of The Dayton Foundation.


Greenlight Grants

To better assist Greater
Dayton nonprofits in need of
funding for small projects, The
Dayton Foundation launched
Greenlight Grants in 2016.
This quarterly, competitive
grants program provides quick
grants, ranging from \$500 to
\$7,500, for special projects,
program expansions, capital
improvements and capacity
building to help nonprofit
organizations make a greater
impact.

Grants totaling \$85,000 were awarded to 22 area nonprofits this past fiscal year.

Strengthening Community Through Discretionary Grants

The Dayton Foundation's discretionary grants to area nonprofits this past year supported innovative and impactful projects that are changing the landscape of Greater Dayton. Support for these projects is made possible by donors who place little or no restrictions on the grants awarded from their funds,
